

Regulations of the Test Dive 2018 Conference

Article 1. General Provisions

1. The Test Dive 2018 Conference (“Conference”) is organised by Nokia Solutions and Networks Sp. z o.o. with its registered office in Warsaw, address: ul. Rodziny Hiszpańskich 8, 02-685 Warszawa, entered to the Register of Entrepreneurs of the National Court Register maintained by the District Court for the Capital City of Warsaw in Warsaw, 13th Division of the National Court Register under KRS number 0000265262, NIP 113-26-39-219, REGON 140718341, share capital of PLN 14,375,000,00 (hereinafter the “Organiser”).
2. The Conference will be held on 18 October 2018 in Kraków. The venue of the Conference will be at Multikino at: ul. Dobrego Pasterza 128 in Kraków.
3. The Conference is addressed to natural persons (hereinafter referred to as Participants) and its objective is to gather the best presenters, engineers and practitioners to ensure high quality lectures and will initiate interesting discussions related to the quality and testing of software. The Conference may be attended in particular by persons professionally involved in the subject of the Conference and students, representatives of academic circles and partners to the Conference.
4. These regulations set forth the rights and obligations of the Conference participants and the Organiser.

Article 2. Conditions for participation in the Conference

1. The Conference may be attended by persons who have declared their interest to participate in the Conference and have received an invitation from the Organiser to the specified e-mail address. The number of participants is limited.
2. Participation interest will be reported by completion of the participation form on the testdive.pl site and approval of these regulations, providing consent for personal data processing and consent to use the image.
3. In the participation form, the Participant will provide the following information: first and last name, email address, telephone number, city of residence, company/university, position. If incorrect or incomplete data is provided, the invitation to the Conference will not be offered.
4. The participation in the Conference is free of charge. The costs of stay and arrival to the Conference shall be covered by the Participants.

5. The Participants accept that the Conference will be filmed and photographed by the Organiser for promotional and information purposes and to publish a report from the Conference. In the enrolment process, Participants will be requested to provide their consent to use the image recorded during the Test Dive 2018 Conference in the form of photos, films and recordings and to the distribution thereof by Nokia Solutions and Networks Sp. z o.o. with its registered office in Warsaw. Such consent will cover such forms of publication like: publishing the image on the web sites www.testdive.pl and www.nokiakrakow.pl, social media, promotional and information materials for promotional and information purposes and to publish a report from the Conference. The consent shall cover multiple publication of the image without time or territorial restrictions.
6. Participants may resign from attending the Conference. Any resignation by a Participant should be done by a message sent to the email address: test.dive@nokia.com.

Article 3. Organisational aspects

1. The program of the Conference is available at: testdive.pl. The Organiser reserves the right to change the Conference program at any time. Modifications will be published at: testdive.pl.
2. The Organiser reserves the right to change the date, venue or duration of the Conference. Participants will be informed on any modifications to the time or venue of the Conference by email.
3. Participants will be registered and issued IDs on the Conference day. Participants are obliged to show their invitations to the Conference and place the ID in a visible place.
4. Conference Participants are obliged to behave in a manner not posing hazards to other people, in particular to comply with security rules, including OH&S regulations, fire regulations in force at the venue of the Conference, as well as the organisational and technical instructions and commands by the Organiser and facility administrator.
5. It is strictly prohibited to advertise any other brand at the Conference apart from Nokia unless subject to the Organiser's approval. The persons who break the prohibition will be requested to leave the Conference.

Article 4. Liability of the Organiser

1. The Organiser shall not be liable for any things left, lost or stolen during the Conference.

2. The Organiser shall not be liable for any damage caused by the Participants during the Conference. Conference Participants shall be fully liable legally and financially for damage caused by their activities or omissions.
3. To the extent permitted by Polish law, the Organiser excludes its liability for any damage suffered by Participants in connection with the organisation, performance, revocation or postponement of the Conference date.

Article 5. Personal data

1. The Organiser shall be the controller of the Participant's personal data. The Organiser will transfer the Participants' personal data in compliance with Nokia's Privacy Policy, subject to Art. 5.2-8.
2. Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, constitutes the legal basis for Participants' personal data processing - Article 6.1.a), b), f).
3. The purpose of the processing of the Participants' personal data is to make it possible for them to attend the Conference.
4. The following personal data categories of Participants will be processed: first and last name, email address, telephone number, city of residence, company/university, position.
5. The Participants' personal data will be stored for the purpose specified in Art. 5.1, during the organisation and term of the Conference and after it has ended, to the extent required to determine, pursue and defend claims.
6. Participants shall be entitled to demand access to their personal data, to have it corrected and - as far as permitted by applicable laws - to have it deleted, to have the processing thereof restricted or to object to have it processed.
7. Participants shall be entitled to revoke their consent for their personal data processing at any time which however shall not affect the lawfulness of the processing performed on the basis of the prior consent.
8. Participants may file complaints with the President of the Personal Data Protection Office, ul. Stawki 2, 00-193 Warszawa.
9. The provision of the personal data is required to accomplish the purpose specified in Art. 5.1.
10. The Participants' personal data will not be used to take automatic decisions in individual cases, including related to profiling.

Article 6. Final provisions

1. Any disputes that may result from attending the Conference shall be resolved by a court competent for the Organiser's registered office.
2. The Organiser reserves the right to revoke the Conference at any time. Conference Participants will be notified by email on the revocation of the Conference.
3. The Organiser may modify the provisions of these regulations. Such modifications will become effective at the time specified by the Organiser which may not be shorter than 14 days of notification to the Participants by email. Such updated regulations will be published on the web site: testdive.pl.
4. These regulations become effective on 27 August 2018.
